*Activities or programs that are beneficial to the community but cannot be carried out by OLE

- * Activities must align with policies and or legal duties of the OLE
- Subsidized organizations should possess the expertise in the field for which subsidy was granted
- * Subsidized organization must exercise the ability to generate own income.

- DESIGNATED STAFF IN DIRECTORATE CHARGED WITH SUBSIDIY PORTFOLIO
- Subsidy amounts are evaluated

- Subsidy amounts not adjusted based on performance
