QUESTIONS:

On May 21st we received the answers to Council Sneek questions as it pertains to the roaming animals, below are follow up questions based on the answers provided.

- 1. "How many animal owners have signed such an agreement?
 - a. Is an agreement in place now? If no, what is the set timeframe?
- 2. What phase of the grace period are the farmers currently in?
- 3. "Clearing crucial areas of roaming animals and reducing the number of livestock on the island is only part of the project. The other goal is to create alternatives for livestock owners. What alternatives are being worked on and what is the status of this part of the project? We are working on an agriculture vision plan where animal husbandry is also taken in consideration."
 - a. When will be Vision Plan be ready/ available?
 - b. What is the next phase after the grace period is completed?
 - c. Is the next phase based on a plan in the event the Vision plan is still not completed?
 - i. If Yes, Please provide a copy of such plan.

ANSWERS:

- 1a. Agreements are not signed yet. The directorate of Economy, Nature & Infrastructure agreed about the content of 3 agreements with 3 families of animal owners. The draft agreement for the first family is made ready to be signed by the Executive Council in July. This agreement will be used as a format agreement for the rest of the families to be signed quicker.
 - When spoken to the Public Entity St. Eustatius and agreed on conditions and tasks, this can be considered as a draft agreement (as for the 3 mentioned families) until the formal agreement is in place.
- 2. Since April 30th the grace period only continues for animal farmers that are registered at the Chamber of Commerce and who agreed with the Public Entity St. Eustatius to remove their roaming animals. These animal owners will continue to benefit from the provided incentives. The inducements have been discontinued for non-registered farmers and hobby farmers as of April 30th 2021.

The inducements are still the same as since the start of the grace period, October 20th, 2020, which include reduced fees for fencing materials, financial compensation equivalent to the slaughter fees, a higher price for their animals at the slaughter house and access to other subsidized materials.

- 3a. The Agricultural Vision plan is send to the Executive Council for approval for their meeting of June 22nd.
- 3b/c. The grace period is part of the project Roaming animals. The Agricultural vision is a policy document to further develop the agricultural sector of Sint Eustatius. The Agricultural vision plan is not a part of the project Roaming animals, but to successfully execute the project Roaming animals, implementation of a lot of actions of the Agricultural vison are necessary.
 - The next phase in the project Roaming animals is to keep removing the cows from the urban area and continue to make preparations to fence the rest of the roaming animals. Depending on the approval of the Agricultural vision more implementation actions will follow. There is no separate plan.
