Nr.	Question	Answer
1	If the money is available, why is the payment terms set on 30 days? Could this be reduced? Contractors are not BANKS	30 days is the formal <b>maximum</b> term of the Employer. This term can't be changed for individual projects.
2	Could they reduce the validity date of the bid? Reason all prices of materials and shipment are rising still every day/week/month. This is hard to predict. Some companies give you a quote with validity of 5 days.	This can't be reduced. 90 Days is the <b>maximum</b> Bid Validity period and is necessary in case of irregularities or legal processes.
3	The award process should not take that long to keep this on 90 days? What about 30 days?	Normally a period of around 30 days is possible, but in case of irregularities or legal processes it shall take a longer period.
4	Will the construction works at Airside be executed under the aircraft liability insurance from the Airport?	See text related to Aviation Legal Insurance in part 2, appendice 03 Operational Management Airside, paragraph 1.6 Additions with respect to the performance.
