Specs 2.2.9.	5 year for steel overhead door and rolling doors is only possible for the parts not for the moving parts. This is not possible to get. Unless you can provide us a supplier will give this.	"5 years for steel overhead doors including accessories" change in "1 year for steel overhead doors including accessories". The client itself concludes maintenance contracts in order to extend the warranty after the first year.

Specs 5.42.90- 10	"The contractor shall provide personnel for doing measuring work, at the request of the supervisor". What measurements will this be and how many people need to be used for this?	Incidentally 1 person to assist when checking measurements. Prepare test cubes when pouring concrete.

	Specs 30.90.10	There is a 5-level key system, can you provide more details about this? Please inform how many keys under which level? And how many extra keys need to be provided on each level.	To count on a key hierarchy of 5 levels. 5 pieces master keys, 10 pieces master keys and 3 pieces keys for all doors divided into three different groups.
	Specs 41.30.10	Wall tiles. 41.30.10 mentions an allowance of \$ 20,- for wall tiles. Please consider a higher price for on site delivery, \$ 25,- will be closer to the reality. Width of all furniture as shown in the drawing. Each unit over the full width with lower cabinets with 1 shelf, upper
